4. New Business

- a. Hiring regular pool service that comes at least once a week, vacuums, checks water chemistry, etc. Our volunteer CPO could coordinate & oversee this vendor? Eilis received one quote for \$1,200/month which includes: 2x week service, chlorine and acid, chemical tests/records, floor vacuum, pool wall brush, clean top netting..etc. Board to pursue additional quotes. Eilis to obtain a quote from the first bidder for the winter months as well.
- b. Purchasing an automatic vacuum for the pool- Daniel is working on getting a quote from Leslie's pool supply.
- c. Consider having Lifeguards check the pool chemistry at the beginning of their shift and enter it into a daily log? Kristine is checking the chemistry now and updating the supply list for needed supplies. She will have the lifeguards check after the swim team ends. (write-up and training needed)
- d. Ideally, it would be best to have our Chemtrol unit, be a wi-fi unit, so it could notify us remotely of water chemistry. Per James: I understand in 2019, when we replaced our Chemtrol Unit, the LRCC board decided against the wi-fi unit. I believe it is typically a difference of \$700-900. Next time we replace our chemtrol unit, I think it is absolutely necessary to have the wi-fi model.

- f. Motion by Celeste Gaither: Appoint Sue Ott as interim membership chair with all rights and privileges. Eric seconds; motion passed.
- 5. Reports of Officers, Boards, Standing Committees
 - a. President:
 - i. Ordered some new signs, many required by the health dept, including No Guard on Duty, CPR, Pool Capacity, etc. In addition, we have 2 new safety signs now posted at the pool.
 - ii. Ordered some basic pool chemical safety protective equip, Apron, Eye protection & gloves.
 - iii. On the 4th of July, Lindsey, noted that children kept slipping on the smooth concrete in front of the fridge. I purchased a small rubber mat and have placed it in front of the fridge, think this will make it a bit safer. Thanks Lindsey for the keen observation.

- iv. I have finished mounting a simple rack for holding mops, brooms, etc. It is located by the BBQ area sink.
- v. I have hung the new mirror in the unisex restroom.
- vi. I have the lap lane rope at home, making a few modifications and will bring it back to LRCC on Thursday.
- vii. I am working on following up on our new AED, which still has not arrived. I called the company last week and have not yet heard back from them. They were backordered at one point. I will continue to follow up and keep everyone posted.
- b. Vice President: Worked with Lindsey and the social committee to be successful in their event. The committee seems to be happy in their role and the success of the events.
- c. Treasurer: 111% of budgeted membership; fixed the sub accounts of a few items, action item for Geoff to follow up with James about Lowe's receipts to make sure they are under the correct sub account; Look at the reserve study at the next board meeting; QuickBooks needs be fixed
